# Revisions Made To FY2010 (86<sup>th</sup> Period) Dividend Projections

At the meeting of board members held on February 7, 2011, Sumitomo Metal Mining Co., Ltd. (SMM) revised its dividend projection as shown in the table below.

## 1. Reasons behind Revisions:

Based on its profit allocation policy, SMM has revised its annual dividend projection to JPY30.00 per share in reflection of the FY2010 consolidated earnings forecasts announced today. As a result of this, the year-end dividend projection has been revised from the previous projection and has increased by JPY6.00, to JPY18.00 per share.

This revised annual dividend projection represents an increase of JPY10.00 compared to the previous fiscal year.
