In line with the theme of the 2021 3-Year Business Plan, "Renewed Challenge for Change," that we announced in February, the theme of "Change" is persistent throughout this entire Integrated Report. We are going to go into detail on the primary points of concern for stakeholders, such as our "Vision for 2030" initiatives aimed at the realization of our long-term vision, our response towards changes in the social environment through our 2021 3-Year Business Plan, substantive initiatives for our new attempts at the Change and more. Through this report, we hope to garner even further understanding from all of our stakeholders inside and outside of the company with regard to the initiatives we are undertaking toward our group's goal of achieving sustainable growth and maximizing corporate value. We also hope to use this report as a means of engagement with our stakeholders.

- Main Features of the Integrated Report 2022
  - 1) Creation of the At a Glance page We have newly created the At a Glance page at the beginning of our Integrated Report so that first-time readers can get an overview of our company.
  - 2) Inclusion of a section about our impacts on society through our group's business model and value creation We further quantify and explain the details of each process behind the mechanisms that produce the SMM Group's own unique value creation with the goal of elucidating the characteristics of that value creation process. Moreover, we have included a section about the impact of our group's business activities on society as "IMPACT." Further, we have got a detailed depiction that explains our business model.
  - 3) 2021 3-Year Business Plan Overview We have got a detailed description of the 3-Year Business Plan that we will be starting in FY2022, along with where we plan to end up, and details for initiatives each business division will be engaging in towards that plan. The lead-in is a message from the president with his aspirations towards the current 3-Year Business Plan.
  - 4) Special Feature: Sumitomo Metal Mining Group's Digital Transformation We are going to talk about the hurdles we face with the promotion of digital

transformation and what we are doing to overcome them, our roadmap, priority areas, and more. Additionally, we are going to introduce substantive initiatives that are taking place at each base.

- 5) Specification of the progress and goals of our Material Issues in Vision for 2030 We go over the progress we have made in each of the 11 material issues in our Vision for 2030 over the last year, including their KPIs. Further, we specify each of the 3-Year Business Plan's goals to be accomplished and their action plans as well as define the route to the accomplishment of our goals for FY2030.
- 6) Separate volume for detailed data related to sustainability
  We compile selected data into a separate volume called "ESG Data Book 2022," just as
  we did last year. We are trying to maintain the quality and amount of data we disclose
  while keeping it easy to read.
