## Sumitomo Metal Mining Publishes the Integrated Report 2024 and the Sustainability Report 2024

Sumitomo Metal Mining Co., Ltd. (TSE: 5713) has today published the Sumitomo Metal Mining Integrated Report 2024 and the Sumitomo Metal Mining Group Sustainability Report 2024 in English. Due to society's demand for earlier reporting of financial and non-financial information, the Company is publishing the reports about two months earlier than it did in the previous fiscal year.

Sumitomo Metal Mining publishes two reports to disclose its business activities, the Integrated Report, which summarizes financial and non-financial information focused on the Group's value creation process, and the Sustainability Report, which summarizes a wide range of non-financial information including detailed data.

Both reports published in 2024 cover that what the Sumitomo Metal Mining Group has heretofore engaged in towards the resolution of social issues through its business, and the thoughts of its new President, who was appointed in June 2024, on change in management strategy.

In order to realize its long-term vision of Becoming the World Leader in the Non-Ferrous Metals Industry, Sumitomo Metal Mining has established Vision for 2030 to set the Group's long-term direction. The Company aims to contribute to the sustainable development of society and increase its corporate value by implementing specific business activities based on 3-Year Business Plan. Sumitomo Metal Mining will strive to enhance its disclosure of financial and non-financial information in accordance with those directions.

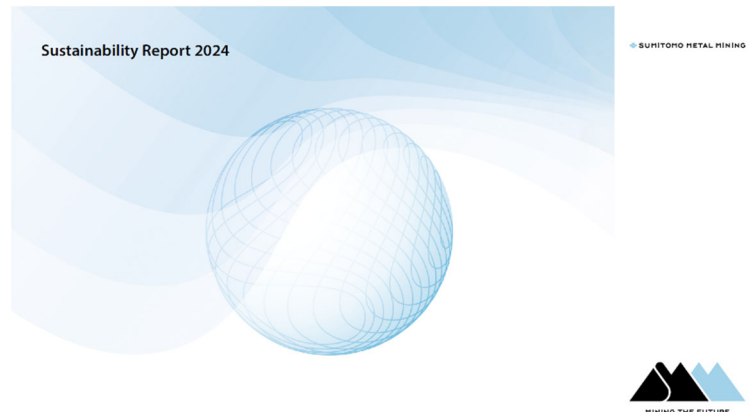
### <Key Points of Sumitomo Metal Mining Integrated Report 2024>

- In response to the requests of stakeholders, it includes features on Carbon Neutral, Tailings Facility Management, and Human Rights.

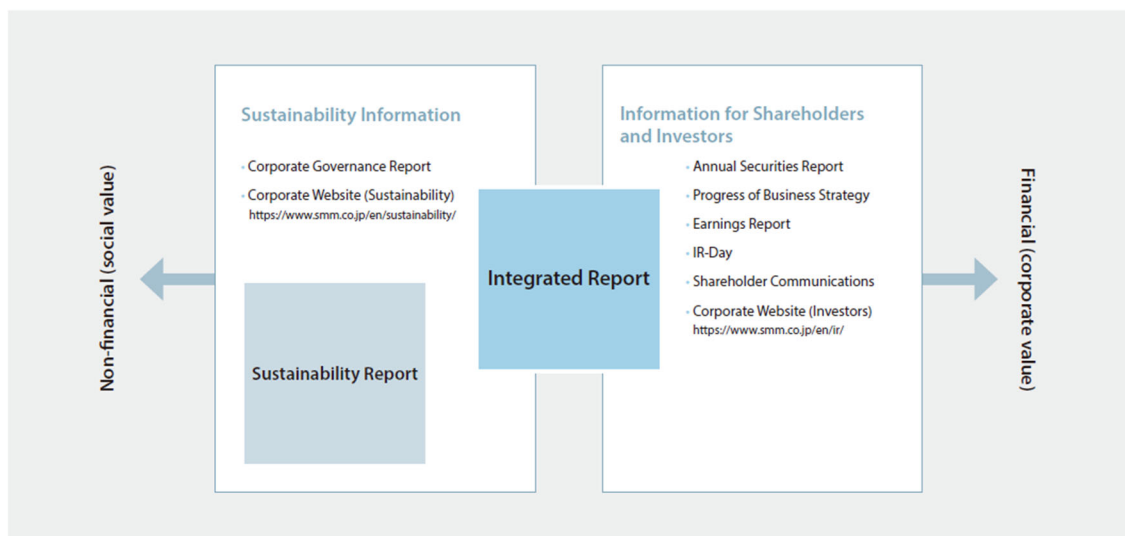
### <Key Points of Sumitomo Metal Mining Group Sustainability Report 2024>

- It describes in detail its sustainability management system, with the Sustainability Committee chaired by the President.
- It discloses information complied with the GRI Universal Standards.
- It discloses the state of its compliance with the principles of the International Council on Mining and Metals (ICMM), an industry group to which Sumitomo Metal Mining belongs.

(\*) The comprehensive business model covers from resource development to smelting and refining, and production of highly advanced materials through organic collaboration among the Company's three businesses: Mineral Resources, which performs mine development and operation, Smelting and Refining, which creates metal materials from those mining resources, and Materials, which adds new value to the materials.
